

# Irradiant Ltd. eFiler Licence Agreement

# 1. Grant of Licence

- This software is licensed, not sold.
- You are granted a non-exclusive, non-transferable licence to use eFiler according to the terms of this agreement.
- You may install and use eFiler on as many computers as you have purchased licences for.
- Installation of eFiler on any shared computing environment (including but not limited to terminal servers, Remote Desktop Servers, or Citrix environments) is strictly prohibited unless explicitly authorised in writing by Irradiant Ltd. and subject to an appropriate multi-user licensing agreement. Each user accessing eFiler in such an environment must hold an individual, valid licence.
- Each licence is assigned to a single individual and is intended solely for that user to process their own sent or received emails. Sharing a licence across multiple users is strictly prohibited.
- You cannot sublicense, resell, rent, or distribute the software to third parties.

# 2. Agreement & Acceptance

- By installing, accessing, or using eFiler, you accept this agreement.
- If you do not agree, do not install or use the software.

# 3. Customer Responsibilities

- You must ensure your hardware meets the minimum system requirements.
- You agree to use the software in compliance with all applicable laws and regulations.

# 4. Support & Maintenance

- Support is available only while you have a valid maintenance or subscription plan.
- Updates and upgrades require an active maintenance or subscription plan.
- When considering email support or remote support sessions, you must:
  - Treat Irradiant Ltd. staff with respect.
  - $\circ$   $\;$  Remain present for the full duration of any support session offered.
  - $\circ$   $\,$  Provide access to necessary logs and diagnostic information.



- Respond in a timely manner and answer all questions asked in detail.

- To ensure the best experience, we periodically phase out support for older versions. Customers will receive advance notice whenever possible.

# 5. Online Service & Availability

- While we strive to maintain reliable service, occasional downtime may occur due to maintenance, network issues, or external factors beyond our control.
- We are not liable for any losses, damages, or inconvenience caused by service interruptions.

## 7. Subscription, Renewal & Termination

- Automatic renewals: Licences renew automatically unless cancelled at least 14 days before the renewal date.
- Price changes: Subscription prices may change, and the latest pricing is always available on the website.
- Termination: Irradiant Ltd. may terminate your licence immediately if you:
  - Violate any terms of this agreement.
  - Attempt to reverse-engineer, modify, or tamper with the software.
  - Use the software in an illegal or unauthorised manner.
- Upon termination, you must cease use of eFiler and delete all copies.
- The customer is responsible for all costs arising from failed or declined payments, including any third-party processing fees, chargeback fees, or charges incurred by Irradiant Ltd. due to such failures.

- You may not attempt to bypass, modify, or interfere with licence verification mechanisms.

- Continued use of eFiler after updates means you accept the new terms.
